# PUBLIC HEARINGS THIS WEEK INTO E-SCOOTERS, E-BIKES AND RELATED MOBILITY OPTIONS

### FOR RELEASE AT 6.30 AM 29 OCTOBER 2024

The Upper House committee examining the use of e-scooters, e-bikes and related mobility options will hold three public hearings this week on Tuesday 29, Wednesday 30 and Thursday 31 October 2024.

The committee will hear from a diverse range of witnesses over the three hearings, including users, operators of share bike schemes, local councils, medical associations, peak bodies and community organisations. Witnesses from the NSW Government and the NSW Productivity and Equality Commission are also scheduled to appear.

The Chair of Portfolio Committee No. 6 – Transport and the Arts, Ms Cate Faehrmann MLC, stated: 'There's no doubt that e-scooters and e-bikes have made it easier for many people to get around, however, New South Wales hasn't kept pace with other jurisdictions in regulating these devices, which is understandably leading to frustration in the community. The committee will closely examine the regulatory framework governing the use of e-mobility devices, including the NSW Government's announcement this week, to ensure the growing number of people using these transport options are wellsupported and safe, along with other road users and pedestrians'.

As part of the inquiry process, members of the public were invited to complete a questionnaire in lieu of making a submission, with 1,298 people taking part, including 467 people who identified as light electric vehicle users and 353 as pedestrians. Some of the key findings from the questionnaire include:

- The environmental benefit of reducing emissions as well as the potential to reduce traffic congestion, and faster and convenient commuting are among the most important factors determining the choice to use e-mobility devices.
- There is considerable concern about safety, especially regarding the use of devices on shared paths. Many highlighted the need for enhanced infrastructure and clearer regulations.
- Many expressed a need for clear technical standards for e-mobility devices, targeted enforcement against dangerous behaviours, and comprehensive user education.
