Barbara Joseph and her two sons, Paul and Matt Jones (in training partnership) suspended for 4 months re death of I Am Rocky on 24 February 2019 in his stable box.

# Horse death results in suspension

Racing New South Wales has suspended three members of a training partnership for failing to provide adequate veterinary treatment to one of their horses.

Canberra trainers Barbara Joseph, Paul Jones and Matt Jones fronted Racing NSW stewards on Wednesday at the continuation of an inquiry that was opened on May 19 this year.

It was in relation to the circumstances surrounding the death of I Am Rocky in February this year and the care the four-year-old entire was afforded in the lead-up to its death.

In addition to one charge under AR103(4), for failing to lodge a stable return for I Am Rocky despite the horse having been in work for approximately nine weeks, the training partners were also issued one charge under AR231(1)(b)(iii).

Among the particulars of that charge were:

\* At approximately 4am on Saturday, 23 February 2019, co-trainer Mr M. Jones became aware that I Am Rocky was displaying symptoms of colic.

- \* At approximately 8:09am on Saturday, 23 February 2019, Mr P. Jones became aware that I Am Rocky was again displaying symptoms of colic.
- \* That during Saturday, 23 February 2019, stable foreperson Mr S. Jamieson had observed that I Am Rocky had "been lethargic all day".
- \* That during Saturday, 23 February 2019, they did fail to provide for veterinary treatment of I Am Rocky when the horse was displaying symptoms of colic and such treatment was necessary for the horse.
- \* That after observing that I Am Rocky was dull and lethargic in its stable at approximately 7am on Sunday, 24 February 2019, licensed stablehand Ms L. Fehre contacted Mr S. Jamieson soon after and reported to him words to the effect "He looks unwell and he probably needs a vet".
- \* That at no time did they, subsequent to Saturday, 23 February 2019 and whilst I Am Rocky remained in their care, control and supervision at their registered racing stables provide for veterinary treatment of the horse, when such treatment was necessary for the horse.
- \* I Am Rocky was found deceased in its stable at approximately 7:30pm on Sunday, 24 February 2019 by stable foreperson Mr S. Jamieson.
- \* A post-mortem examination report completed by Dr S. Raidal, Veterinary Diagnostic Laboratory (Charles Sturt University), on 26 February 2019, provided a gross diagnosis of right dorsal displacement of the large colon, likely secondary to diffuse typhlocolitis ultimately was the cause of the death of I Am Rocky. The Report also identified and described numerous superficial wounds and subcutaneous haemorrhages, consistent with trauma following an episode of uncontrolled colic pain.

AR231(1) states that it is an offence for any person in charge of a horse to fail to provide veterinary treatment to a horse when necessary.

The four-month suspension under the second charge was reduced from six months owing to a guilty plea from the three training partners, while they were also fined \$200 under charge one.

On Thursday, **23rd May 2019**, **an inquiry was opened** into the circumstances surrounding the death on the evening of Sunday, 24th February 2019 of I Am Rocky, a 4YO bay entire, whilst it was in the care of the Joseph Jones Racing Partnership, and also into the care that the horse was afforded in the lead up to its death.

Evidence was taken from the co-trainers of the training partnership consisting of Mrs Barbara Joseph, Mr Paul Jones and Mr Matt Jones, and stable foreperson Mr S. Jamieson, stablehand Ms L. Fehre, **registered owner of I Am Rocky, Mr C. Warne,** Dr J. Laing – Bungendore Veterinary Surgery and Dr Toby Koenig – Chief Veterinary Officer RNSW. Ms L. Hours attended the inquiry as a support person for Mr Warne.

The inquiry was continued today with further evidence being taken from Mrs B. Joseph, Mr P. Jones, Mr M. Jones, Mr C. Warne, Dr J. Laing and Dr T. Koenig. Ms L. Hours again attended the inquiry as a support person for Mr Warne but also provided evidence.

Mrs B. Joseph, Mr P. Jones and Mr M. Jones pleaded guilty to the following two charges:

Charge 1

Under *AR103(4)* that they did fail to lodge a stable return for the four-year-old horse I Am Rocky, which after joining the Joseph Jones Racing stables, had been in active work for a period of approximately nine weeks.

- had "been lethargic all day". (7) That during Saturday, 23 February 2019, they did fail to provide for veterinary treatment of I Am Rocky
- when the horse was displaying symptoms of colic and such treatment was necessary for the horse. (8) That after observing that I Am Rocky was dull and lethargic in its stable at approximately 7am on Sunday,
- 24 February 2019, licensed stablehand Ms L. Fehre contacted Mr S. Jamieson soon after and reported to him words to the effect "He looks unwell and he probably needs a vet".

#### **PENALTY**

CHARGE 1 - Fined \$200.

CHARGE 2 – 4 months suspension, reduced from 6 months on the entering of a guilty plea. In further assessing penalty, amongst other considerations, recognition was given to this being the partnership's first breach of a related Rule, the licensing history of the members of the training partnership and the scale of the training operation.

Under the provisions of AR283(7) the committee of Stewards deferred the commencement of the period of suspension for 7 days which permits the training partnership to continue to train and racehorses up to and including Wednesday, 3 July 2019.

Mrs B. Joseph, Mr P. Jones and Mr M. Jones were advised of their right of appeal to the ACT Racing Appeals Tribunal.

# **Stewards Issue Everest Whip Rule Warning**

## By Ray Hickson

Significant financial penalties, including loss of winning percentage, or even a protest will come into play if any rider flouts the whip rules in Saturday's \$10 million The TAB Everest.

Racing NSW chief steward Marc Van Gestel has warned stewards will take a negative view of any jockey that deliberately breaks the rules of racing in the feature sprint at Royal Randwick.

Van Gestel said on race day stewards will inform all 12 jockeys involved, who stand to win around \$290,000 for their percentage of first prizemoney, of their obligations under the rules of racing.

"We want the race run according to the rules and that's all rules, not just the whip rule," he said.

"If they do infringe their requirements to strike the horse no more than five times (before the 100m) potentially there will be significant penalties and that could include the forfeiture of the prizemoney.

"The rules allow us to actually rule the rider forfeits his entire percentage if they offend.

"We want to be upfront with the riders and say that's the deterrent - if you breach the rules that could potentially be the consequence."

Jockey Tye Angland was fined \$4000 after breaking the whip rule in winning the Spring Champion Stakes on Ace High last Saturday.

He used the whip nine times prior to the 100m plus each stride from there to the winning post.

## The rule allows a jockey to strike a horse no more than 18 times in a race.

Prior to the 100m only five strikes are allowed then from the 100m a horse can be hit each stride to the post which is 13 times, provided the horse is responding and still in contention.

"If jockeys in the Everest, or any other race for that matter, are going to exceed the total that Tye Angland did on Ace High they can expect the penalty to be greater than a \$4000 fine," Van Gestel said.

But what about a protest?

Whip rule protests have been rare, and in some states stewards have basically said a whip rule protest could never be substantiated, Van Gestel said it's not out of the question under the right circumstances.

"If there's a significant breach and a small margin it may well be that the stewards could lodge an objection and give consideration to that," he said.

"We've never ruled it out but there may be a case where the stewards can be satisfied that a horse has gained an advantage or sustained its effort for a long period of time with illegal whip use."

RACE 7 – Sweeties Confectionery Benchmark 60 Handicap 1400m Olinoor overraced in the early stages and approaching the first turn was steadied away from the heels of Prince Kristen. Aftadaka overraced badly in the middle stages. B Avdulla (Causin' Havoc) explained that the gelding never handled the heavy track conditions at any stage of the race. A post race veterinary examination of Causin' Havoc did not reveal any abnormalities. Stewards questioned apprentice A Hyeronimus (**Annubas**) relative to the post race condition of that gelding where a veterinary examination revealed **a number of welts** on the horse's thigh. Apprentice A Hyeronimus explained that he had purchased a new whip yesterday and this was the first race in which he had used it, however in his view he had used the whip in a conventional backhand manner and advised that he had not struck the horse with the seam of the padded whip. After viewing the stewards' patrol films which confirmed the evidence of apprentice A Hyeronimus the matter was adjourned pending a detailed inspection of the apprentice A Hyeronimus's whip which was confiscated by the stewards and further a subsequent veterinary examination of Annabus conducted by the stable veterinarian."

#### **Supplementary**

RACE 7 – Sweeties Confectionery Benchmark 60 Handicap 1400m Stewards today concluded their inquiry into the reason for welt marks being found on the hindquarter of **Anubas** following the running of this race. Trainer Mr P Webster advised stewards that a veterinary examination of Anubas the following morning had revealed that the welt marks had subsided and no evidence of any adverse reaction was detected. Stewards referred the whip of App. Hyeronimus to the manufacturer to inspect the whip and insure that it meets the specifications as determined by the Australian Racing Board. Whilst stewards accepted that **App**. **Hyeronimus had used his whip in accordance with the rules** he was nonetheless advised that particularly when riding this horse he should be mindful not to use the whip **in a manner** that may leave welt marks."

It is my belief that when the Stewards refer to "in a manner" refers to this jockey's backhand use of the whip. I do know that the jockeys were perfecting the backhanders because there were no restrictions on them at that time.

The above incident is evidence that the use of the padded whip can cause injury to a horse.

This is the only reported and disclosed incident that I have of a racehorse in NSW sustaining obvious welt marks.

This jockey injured the horse and he was not charged and merely told to be mindful.

INQUIRY INTO THE COLLAPSE AND CATASRPHIC INJURY SUSTAINED BY THE RACEHORSE SANDANEY AT WARWICK FARM RACECOURSE ON 30 DECEMBER 2019.

Stewards: M F Van Gestel (Chairman) T P Moxon T J Vassallo Racing NSW Stewards today conducted an inquiry into a report received relative to the collapse and catastrophic injury sustained by the racehorse Sandaney at Warwick Farm racecourse on 30 December 2019.

Evidence today was taken from trainer of Sandaney Mr Rick Worthington, Stablehand Riders Mr Patrick Shanahan and Mr Bruno Neto, Trainers Mr Clarry Conners and Mr Bryce Heys, ATC Trackwork Supervisor Mr John McGarr, Mr Paul Messara representing Arrowfield Stud, the Owners of Sandaney, and Racing NSW Chief Veterinary Officer Dr Toby Koenig. A report and statement tendered by Dr James Whitfield from Randwick Equine Centre was also considered along with a necropsy report provided by the University Teaching Hospital Camden. Racing NSW Senior Investigator Ms Jacqueline Johnstone assisted the inquiry.

## The evidence disclosed;

- 1. Sandaney was offered for sale at the 2018 Yearling Sales, but was passed in.
- 2. X-rays performed on the gelding in preparation for the yearling sales had revealed both fetlocks to have developed progressive osteoarthritic changes.
- 3. Sandaney was subject to arthroscopic surgery on 16 October 2018, whereby bone fragments were removed from the off fore fetlock joint.
- 4. Advice from the veterinarians was guarded to fair prognosis for Sandaney to race and after spending 12 months spelling under veterinary advice, the gelding was broken in and placed into light work.
- 5. Treatment records obtained from Arrowfield Stud did not reveal any treatments of concern that had indicated any lameness issue whilst spelling.
- 6. On 23 December 2019 Sandaney entered Mr Worthington's Warwick Farm stables for training, following being broken in at Mr Worthington's farm and there were no treatments provided to the gelding. Mr Worthington advised the horse had not displayed any lameness.
- 7. On 30 December 2019 Mr Shanahan rode the gelding in trackwork, however did not adhere to the directions of Mr Worthington to work the horse slow and on the "polo field" track, in that he worked Sandaney quicker then slow and was worked on the Polytrack.
- 8. During its trackwork Sandaney became distressed and commenced to tire near the 400m before collapsing and sustaining fractures to both forelimb sesamoid bones and being humanely euthanaised.

# Mr Patrick Shanahan

Charge 1 – AR231(1)(a) - Mr Shanahan pleaded guilty to a charge under AR231(1)(a) in that he committed an act of cruelty to Sandaney on the morning of 30 December 2019 by;

1. Despite being given instruction by trainer Mr Rick Worthington to work the gelding two laps slow on the "polo field" track (circumference 1000m) he decided without permission

of trainer Mr Rick Worthington to work Sandaney two laps on the Polytrack (circumference 1700m).

- 2. He worked Sandaney faster than slow work on the Polytrack and over a longer distance than instructed which contributed to the horse commencing to become distressed and tire near the 400m on the second lap of work.
- 3. He then committed an act of cruelty in that that he mistreated Sandaney by
- a. Using a non-approved whip unreasonably and/or excessively on the gelding over the final 400m.
- b. Continuing to encourage the gelding by pushing and/or riding it out over the final 400m
- 4. Such actions detailed above contributing to Sandaney collapsing near the winning post and sustaining catastrophic fractures to both forelimbs and being euthanaised.

Penalty: 18 months disqualification reduced to 13  $\frac{1}{2}$  months for guilty plea. Disqualification commences 30 December 2019, the day Mr Shanahan was stood down, and to expire on 13 February 2021.

Charge 2 – AR132(1) – Mr Shanahan pleaded guilty to a charge under AR132(1) in that he carried a whip of design and specification not approved by Racing Australia at trackwork on 30 December 2019

Penalty: \$500 In assessing penalty for both charges Stewards took into consideration Mr Shanahan's guilty plea, his good record and remorse he exhibited. However, the Stewards also considered the seriousness of the matter and actions of Mr Shanahan. Further, the general principles that apply when issuing penalty

- 1. What message is to be given to Mr Shanahan to ensure that in the future this type of conduct is not repeated.
- 2. What general message is sent to the community at large to indicate to those who might be likeminded to engage in such conduct, what the likely consequences are.
- 3. To indicate to the broader community who are not likely to engage in the type of conduct that, should it be detected, the industry is operating at the highest possible welfare standards and serious penalties apply for those who breach the horse welfare rules.

Mr Rick Worthington

Mr Worthington pleaded guilty to a charge under AR103(4)(b) in that he failed to lodge a stable return for Sandaney when it entered his stable on 23 December 2019.

Penalty: \$400 (first offence)

Relevant Rules

AR 231 Care and welfare of horses

- (1) A person must not:
- (a) commit or commission an act of cruelty to a horse, or be in possession of any article or thing which, in the opinion of the Stewards, is capable of inflicting cruelty to a horse;

AR 132 Limits on the use of a whip by a rider

(1) A rider may only carry in races, official trials, jump-outs, or trackwork a padded whip of a design and specification approved by Racing Australia ("approved whip") which is in a satisfactory condition and has not been modified in any way.

AR 103 Trainers to lodge Stable Returns

- (4) The trainer of a horse must:
- (b) lodge a stable return immediately upon a horse joining the trainer's stable;

\$7/1						The fact horse appeared not to suffer abrasion en route, was not fractious in the barriers, did not suffer any interference or strike the running rail, tells me that horse sustained this abrasion from whipping, especially when the Stewards asked him to explain how horse sustained the abrasion, which is highly unusual.
						Never come across Stewards asking a jockey to explain the appearance of an abrasion on a horse post race.
						I believe whip marks were obvious in the vetting for the Stewards to take such action.
						Jockey is right handed (offside flank).

**ABRASION -** Some dictionary meanings as follows:

The process of wearing <u>away</u> a surface by friction.

In <u>dermatology</u>, an **abrasion** is a <u>wound</u> caused by superficial damage to the <u>skin</u>, no deeper than the <u>epidermis</u>. It is less severe than a <u>laceration</u>, and bleeding, if present, is minimal. Mild abrasions, also known as *grazes* or *scrapes*, do not <u>scar</u> or bleed, but deep abrasions may lead to the formation of scar tissue. A more traumatic abrasion that removes all layers of skin is called an <u>avulsion</u>.

Abrasion injuries most commonly occur when exposed skin comes into moving contact with a rough surface, causing a grinding or rubbing away of the upper layers of the epidermis.

# By degree[edit]

- A first-degree abrasion involves only epidermal injury.
- A second-degree abrasion involves the epidermis as well as the dermis and may bleed slightly.
- A third-degree abrasion involves damage to the subcutaneous layer and the skin and is often called an avulsion.

#### **NOTE:**

In the Sydney Morning Herald on 12 September 2011 there was an article written by Max Presnell which referred to a horse sustaining welt marks on the flank. **I have the newspaper cutting.** 

"Smart Missile went askew in the straight, for which welts on the flank is the latest explanation, and cost himself the main prize.....

Baddock said Smart Missile came out of the Golden Rose 'with a couple of welts on his flank. Even with the padded whips, if you hit the wrong spot around a sensitive area like the flank....' ".

Andrew Baddock is the racing manager for Filipino squillionaire, Eduardo Cojuangco who flew to Australia in his private jet for Smart Missile's race. Eduardo owns Gooree Pastoral, his racehorse stud at Mudgee (have been there and the breaker in is a lovely old bloke who really knows his stuff and is so kind and patient with these babies).

In early 2010, I was at Rosehill and noticed one of Gooree's filly's, Zutara, had been badly whipped by

I took photos. I phoned Gooree and asked if I could email the photos to them, when they received them they phoned me to say that they would show them to Andrew. My email also contained information about the sensitive flank area and how wrong it is to hit the horse there. I just felt that the time had come to approach an owner when I had indisputable evidence at the risk of them not giving a damn. Seems to me that it was worthwhile given the outcome 18 months later – it went public and Baddock took this opportunity and had no reservations in what he said much to the chagrin of others in the industry.
