Project summary

The LSCA funding of \$100,000 will meet 100% of the costs for delivering the "Who am I?" initiative in NSW schools across Granville, Guildford, and Merrylands.

Its primary goal is to explore the concept of identity, providing students with a profound understanding of themselves and others. Leveraging perspective building, participants are encouraged to step into the shoes of their peers, fostering empathy, understanding, and open dialogue. Ultimately, "Who am I?" aims to teach, direct and nurture individuals, leading to positive contributions to their communities breaking down barriers of miscommunication and prejudice. By promoting self-awareness and fostering interpersonal understanding, the proposed benefits are a marked reduction in conflicts, bullying, and misunderstandings.

The "Who am I?" curriculum will be seamlessly integrated into the regular school timetable as well as offering extracurricular sessions outside of school hours. This dual approach ensures maximum accessibility and inclusivity for all students. It is a 12 to 14 week program delivered by qualified facilitators and mentors.

Recent community surveys have identified a concerning trend in young people with 'identity' issues, particularly those from culturally and linguistically diverse and low socio-economic backgrounds, are grappling with. These challenges are compounded in both educational and social contexts, where many students report feelings of marginalisation. The lack of dedicated programs to address these issues has resulted in a growing waitlist of schools for this program. The demographic trends in Granville, Guildford, and Merrylands, marked by cultural diversification due to population growth and migration, necessitate an urgent response to these challenges.

The "Who am I?" program is designed to resonate deeply with the entire school community, with students being the primary beneficiaries. They will gain a better understanding of their own identities, as well as develop an appreciation for the diverse backgrounds of their peers. This will enhance self-esteem and provide them with tools to navigate a multicultural world. As students grow into empathetic, understanding individuals, they positively influence their immediate communities, fostering a culture of acceptance and unity.
