## (B) THE ESTIMATED COSTS OF THE ALTERNATIVE SITES FOR A NEW ULTIMO PUBLIC SCHOOL

## HISTORY OF ALTERNATIVE SITES FOR A NEW ULTIMO PUBLIC SCHOOL

The current site was dismissed as being unsuitable for future growth, so an Inner City Schools Working Party (ICSWP) was established to best advise on a suitable site. This was replaced by the PRG (Project Reference Group) chaired by Sylvia Corrish (Department of Education), with P&C representatives including life member Bill D'Anthes, Nic Accaria (Principal), City of Sydney representatives, and Department of Education representatives.

13 February 2013: ICSWP discussed the Fig and Wattle site as a prime site for the new school. It was well known that, like every other site in the Sydney CBD and surrounding areas, remediation would be required before construction could begin. The City had undertaken two reports to determine the scope of remediation in previous years.

- 11 Meetings of that committee
- 7 sites investigated

The Fig and Wattle Site was the unanimous first choice, including representatives from Assets Management, demographers, policy staff and administrators, P&C and community representatives, the School Principal and the City of Sydney.

- Cnr Fig & Wattle Street 1.3Ha first choice & recommended \$74M
- 100 Harris Street second choice *now sold* **\$90M**
- 21 Harris Street too small not costed
- 63 Harris Street too small not costed

Other sites were dismissed as unsuitable immediately.

## COSTS OF EDUCATION DEPARTMENT CURRENT PROPOSAL

These expenses are unnecessary when compared to the Fig & Wattle Site build. The costs to relocate 300 students & staff twice by moving to Wentworth Park to substandard demountable classrooms then back again is deplorable. When we asked children about demountable classrooms the worst thing was the noise. Unfortunately, the school demountable classrooms will be right next to Wattle Street which is our busiest road distributor overrun by heavy freight and continuous streams of traffic.

Minister Piccoli in Budget Estimates 2015/16 himself identifies demountable classrooms as:

"Every parent, teacher and student knows that learning in a demountable classroom is no alternative to learning in a real classroom. Our kids should not be languishing in second-rate facilities like demountable classrooms" Adrian Piccoli MP

## (C) THE REASONS THE ALTERNATIVE SITES WERE DISMISSED BY THE GOVERNMENT

## **1 GROSS ERROR IN COSTS BRIEFED TO THE MINISTER** see attached GIPA page 9

The value of the current school (\$49M) was never used as an offset of costs.

Only one quote was sought for full remediation. [i] Industry members suggest this is the most outlandish quote. This kind of pricing sets up NSW taxpayers to be ripped off.

If the Department consistently requires full remediation of all sites, building other schools in the area would be unaffordable.

We believe Treasury convinced the Minister to renege on his Fig & Wattle commitment because this decision is only concerned with short term accounting.

If Treasury could factor the lifespan of the school into the costings, they would realise that \$89.54M for a school on 1.3ha lasting another century, is value for money[ii], as quoted below by the Minister - media release 15 December 2014.

The Department having dismissed the plans for Fig & Wattle, issued a plan to cope with the shortage of student placements. This was to increase the number of classrooms by 40 between Ultimo Public School and Glebe Public School.

However, <u>no</u> extra classrooms are planned for Glebe Public School and only 27 for Ultimo Public School. They do not follow their own suggestions.

The Department suggests to the Minister that demountable classrooms and restricted school catchments can mitigate this shortfall. But this is not possible in this situation, as there is no land for demountable classrooms and the situation is already so ludicrous that the Ultimo Public School was outside its own proposed catchment area.

## Peter Hackney in City News, 22

NOVEMBER 2012: "ULTIMO PUBLIC SCHOOL OUTSIDE ITS OWN CATCHMENT AREA." "The Department has suggested cutting back the catchment area of Ultimo Public School to William Henry Street to cope with enrolment pressures after abandoning plans for a mixed use site of residential apartments paired with a bigger school. This would mean any subsequent cut would see the school outside its own catchment area" - Bill D'Anthes

## **2 NOT VIABLE FINANCIALLY** see attached GIPA page 12

The Minister in his briefing paper from the Education Department was only shown two examples of costings with which to compare the proposed plans for Ultimo Public School:

VICTORIA AVENUE PUBLIC SCHOOL estimated cost \$34.7M - **land given** to Department because the Council couldn't afford to remediate it. It included community facilities and a childcare centre.

ANZAC MEMORIAL PUBLIC SCHOOL - the Department has a 99 year lease - cost \$19.5M. Estimated construction costs \$25M.

If, at the time the Minister was fully informed of other schools which were being planned only 3 months before by his own government, the brief to the Minister may have provided a more balanced view. These schools were major media releases. We are perplexed by the Department's failure to show these costings, which would give the Minister a more balanced view.

Previous media releases just a few months earlier (February 2015) from the Education Department:

- Premier Mike Baird's \$100M pledge for a new combined primary and high school at Parramatta joining Arthur Phillip High
- Interstate Adelaide City High School a 1250 student school is being planned costing \$100M

As Minister Piccoli acknowledges:

"It is more expensive to accommodate those changes in some places. Enrolment pressure in the inner city costs more to resolve than it does in the south-west or on the North Coast". Adrian Piccoli - Budget Estimates 2015/16.

We do not accept the implication that therefore inner city children should be denied the same quality provision for public education as those in suburban or regional New South Wales.

## **3 COMMUNITY CONCERNS FOR THE HEALTH & WELLBEING OF STAFF, STUDENTS & VISITORS TO THE SITE:**

Although we do not agree with the Department that full remediation is needed, we suggest gathering other quotes to protect NSW taxpayers from overpaying for services.

Quotes for the same full remediation:

- Douglas & Partners \$22.54M
- Troy Stratti (Barangaroo Reserve Sandstone Landscape) \$20M-\$30M

The alternative site of Fig and Wattle was dismissed by the government because the Department of Education did not present a balanced and meaningful platform for the Minister to make an informed decision.

## MEDIA RELEASE SHOWING MINISTER UNDERSTOOD IMPORTANCE OF FUNDING A SCHOOL FIT FOR THE FUTURE

## 15 December 2014 Adrian Piccoli Press Release before State Election 28 March 2015

Agreement has been reached for a new public school serving the inner city to be built on a site to be purchased from the City of Sydney on the corner of Wattle, Jones and Fig Streets, Ultimo.

Minister for Education Adrian Piccoli visited Ultimo Public School today and announced that the Department of Education and Communities has agreed in principle to accept a recently revised offer of sale from the Council of \$74 million for the site.

"More families are choosing to live close to the city and the NSW Government is responding to the needs of this growing population. I am sure this agreement will be very welcome news," Mr Piccoli said.

## "Ultimo Public School has been on its current site for 100 years and it needs space to grow as it prepares to deliver quality public education for another century.

"The school currently has 335 students and will soon be reaching capacity. The new site will ultimately accommodate up to 1,000 students.

"The new site is a significant investment by the NSW Liberals & Nationals Government to cater for local growth in student numbers well into the future, playing an important role in maintaining the area's desirability for inner-city residents," Mr Piccoli said.

"Childcare and after school hours care facilities will also be built to support the area's position as a vibrant and diverse residential hub.

"Final details of the sale are to be agreed between the Department and the Council.

"The Department accepted the Council's revised offer on the basis of recommendations by the Inner City Schools Working Party, established by the Minister to address the increase in school-aged children in the inner city.

"Following community consultation about the area's future education needs, discussions with the Council over the site began in November last year. The project to build a new public school in Ultimo/Pyrmont was announced in the 2014 State budget."

We believe that the Minister got it right when he agreed to purchase 1.2ha land for Ultimo Public School. He was aware of the increased demand for student places and their need for adequate playing space. The school cannot continue to rely on public space such as Wentworth Park - the children only have 2-3 40 minute sessions per week on the Park now.



#### Briefing for the Minister

Ultimo/Pyrmont Public School – recommendation not to acquire the Wattle, Jones & Fig Street site due to higher than anticipated decontamination costs

The construction of the Ultimo/Pyrmont Public School on the City of Sydney Council site on the corner of Wattle, Jones & Fig Street, Ultimo is no longer viable at the agreed price due to greater than anticipated site contamination and associated remediation costs. It is recommended that the acquisition not proceed. Legal advice supports this action.

#### Key Information

In 2013 the Inner City Schools Working Party recommended that Ultimo Public School be relocated to the Wattle, Jones & Fig Street site as a new Ultimo/Pyrmont Public School, to cater for increasing student enrolments. The Wattle, Jones & Fig Street site was known to be contaminated and the Government Architects Office (GAO) estimated full remediation costs at \$23.27 million (TAB A). The site was valued, in a decontaminated state, at \$100 million. Council was only willing to offer a \$5 million discount for contamination; the Department sought a \$25 million discount. A sale price of \$74 million was eventually agreed, which represented a \$19 million discount for contamination and an \$8 million discount for the provision of a childcare centre; a long contested need identified by the local community.

A recent report (TAB B) by the project management and design consultant team estimates significantly higher remediation costs as detailed below:

- 1.
- Option 1 Partial Remediation \$31.3 million Option 2 - Full Remediation - \$53.9 million 2.

Full details of each Option are contained in the Rationale. Note that a 3rd Option was rejected based on the significant ongoing monitoring, maintenance, site restrictions and reporting, and the unacceptable risk that the contamination could find its way to the surface or onto surrounding sites.

The total cost of the new Ultimo/Pyrmont Public School, based on the current best professional advice to hand regarding contamination levels, is estimated at \$155.3 million for Option 1 and \$177.9 million for Option 2 as detailed below:

- Site acquisition \$74 million
- Construction of childcare centre as agreed with Council \$8 million
- Construction of school \$42 million
- Remediation costs \$31.3 million for Option 1 or \$53.9 million for Option 2

These costs would be reduced by approximately tem through sale of the existing Ultimo Public School site 4(a)

Given the cost risk associated with constructing the new Ultimo/Pyrmont Public School on the Wattle, Jones & Fig Street site the Department recommends that the acquisition not proceed (refer legal advice TAB C). The Department will now focus on redeveloping the existing Ultimo Public School, and surrounding public schools, to ensure the forecast demand for public school places, now and in the future, can be met.

#### Ultimo Public School - remediation costs of Wattle/Fig Street site

#### Rationale

A recent report (**TAB B**) by the project management and design consultant team estimates significantly higher remediation costs than previously advised as detailed below:

- Option 1 Partial Remediation \$31.3 million to partially remediate the site by constructing a shoring wall to restrict the flow of contaminated groundwater; removing contaminated soil up to a depth of 3 metres; placing clean fill over the remaining contaminated soil and capping the site. This option has significant recurrent costs as it will require ongoing monitoring of contaminated groundwater and management of the site to safeguard the health and wellbeing of staff, students and visitors to the site.
- Option 2 \$53.9 million to fully remediate the site by completely removing all contaminated soil to bedrock, removing contaminated groundwater and disposing of both offsite, followed by clean filling the site. This option would ensure a clean site with no ongoing costs for monitoring or site management.

Note that a 3<sup>rd</sup> Option was put forward, at an estimated cost of \$11.5 million, that required no excavation of contaminated soil, with a cap put over the site at current ground level. This option was rejected based on the significant on going monitoring, maintenance, site restrictions and reporting, and the unacceptable risk that the contamination could find its way to the surface or onto surrounding sites.

The Department's recommendation for not proceeding with the provision of a new school on the Wattle, Jones & Fig Street site is based on the following reasons:

1. Community concerns for the health and wellbeing of staff, students and visitors to the site

The site has serious soil and groundwater contamination. Remediation by removal and offsite disposal of contaminated soil and groundwater is the most effective way of guaranteeing the health and wellbeing of staff, students and visitors for the life of the school and beyond. The full site remediation cost is currently estimated at \$53.9 million, but could be higher, as the estimate is based on preliminary investigations only.

The Department's brownfield development experience suggests that the final remediation costs rarely, if ever, come in on or under the estimate of cost. The Department has also had mixed success when opting for site capping only, even with Environment Protection Authority certification. School communities are generally nervous about the site capping methodology for remediating contaminated sites and the ongoing maintenance and reporting costs have been found to be significant.

There is also the potential for reputational damage to the Department, as capped or partially remediated sites must remain on the contaminated site register, which is a public record.

2. Not viable financially

The potential final development cost of the new school on the Wattle, Jones & Fig Street site is more than three times that of any other primary school in NSW. Recent projects that are similar in nature include:

a. Victoria Avenue Public School in Canada Bay - the site was remediated by removal and offsite disposal of all contaminated soil and a new school (28 permanent classrooms) constructed on the remediated site at a total estimated cost of \$34.7 million. The site was provided to the Department at no cost by Canada Bay Council in return for full decontamination and community facilities, including a child care centre, being constructed on the site by the Department.

## (D) THE COSTS OF REHOUSING ULTIMO PUBLIC SCHOOL IN WENTWORTH PARK WHILE THE SCHOOL IS REBUILT

THE EDUCATION DEPARTMENT HAS QUOTED COMMERCIAL IN CONFIDENCE FOR FISCAL COSTINGS.

WE ALSO RECOGNISE HUMAN COSTS:

64,800,000 hours in demountable classrooms compared to NIL.

Classrooms 27% smaller than the existing school.

Contamination in the soil means that the school will need to be built off the ground, including the playground. This will limit the area for the free play our children need, especially as most of them live in high ries apartment blocks.

## (E) THE IMPACT OF THE BAYS PRECINCT DEVELOPMENT ON FUTURE ENROLMENT CAPACITY IN THE INNER CITY

When determining the need for a bigger Ultimo Public School, the Department's analysis into growth plans did not factor into account Darling Square 1500 apartments, due for completion in 2019 or Bays Precinct 16,000 recently proposed.

- Darling Square apartments school-aged children 300 (20% projection)
- Bays Precinct apartments school-aged children 3,200 (20% projection)

We know that 20% projection is underestimating family growth, as evidenced by similar forecasts of Pyrmont's Jacksons Landing having blown that out.

## From 2006 to 2011, children's age group 0-4 years increased 115% - now in our schools

From 2006 to 2011, children's age group 5-9 years increased 28% From 2006 to 2011, children's age group 10-14 years increased 28% The birth rate alone from 2010-2014 increased 13.5%.

## GIPA Briefing for the Minister DGS15/917

### Context

Ultimo Public School is on a 0.54 hectare site. In 2015 the school has 311 student enrolments which are projected to rise to 352 enrolments by 2020. The school currently has 14 permanent and one demountable classroom on site.

The Wattle, Jones & Fig Street site is 1.2 hectares in size. The proposal is to build a new 40 classroom primary school on the site and sell the existing school site to part fund the new school.

In February 2014, the existing Ultimo Public School site was valued at 1(1)

Previous investigations into rebuilding Ultimo Public School on the existing site also recommended that Glebe Public School be expanded at the same time from 13 to 23 permanent classrooms to allow for student enrolments to be better managed across the two schools.

The estimated cost of redeveloping the existing Ultimo Public School site, and surrounding public schools, to accommodate future enrolment growth is <sup>5(e)</sup> Estimates show that this work will provide an additional 30-40 classrooms, which will accommodate up to 1,000 students.

These figures have not been released.


## (F) ANY OTHER RELATED MATTERS

## **GREEN SPACE IS SEVERELY RESTRICTED NOW**

Wentworth Park is saturated. Lunchtime surveys show green space at a premium. The children share the park with another school, people exercising and relaxing, dog walkers, flotillas of prams, team sports and homeless people.

It is absurd to expect Wentworth Park to cope with twice as many children on 0.54ha. Use of the park is limited to Years 2-6 by roster. They attend after lunch for 40mins during 2-3 visits per week. Their time in a green area is on average 100minutes per week.

Years 2-6 Green Play at Wentworth Park 40 minutes 2-3 times a week only.





K-1 have NO green space playtime. They play on two split level playgrounds devoid of grass. The top playground has a garden at one end with 10 beds: it is soft turf plastic covering concrete. The middle playground is concrete, the size of a basketball court.

Green space is expensive because developers place apartments above other apartments. Our children particularly need green space as most have no backyard.

**INNER CITY PRIMARY SCHOOLS** need as much education and space as other schools. During Budget Estimates (29 August 2016) Mr Piccoli was asked where the school would be built in Green Square (which will be more heavily populated than Ultimo/Pyrmont):

Mr Picolli: "If you can find me six hectares in Green Square, I'm all ears."

This reveals, incidentally, that the Department had no plan, and did not look for space when it was readily available.

In Ultimo/Pyrmont <u>we have found</u> 1.2ha. We need a school there!

## **GREEN SPACE IS VITAL TO OUR LEARNING OUTCOMES:**

Our school garden is loved and cherished.

It has been maintained by P&C volunteers for five years, and has established fruit trees including orange, lemon, double grafted plums, granny smith apple, royal gala apple, coxes orange apple, golden delicious apple, fuji apple, bush tucker trees (macadamia, native lime fingers green, yellow and red plum, blueberry, native ginger).

There are also farmed strawberries, climbing beans snow pea, broad beans, sweet pea, carrots, rosemary, oregano, thyme, mint, various cabbages, and aloe vera.

A Native Bee Hive is fed by our self seeded ANZAC Poppies, purple and white salvia, lavender, spring bulbs, tomato, basil & various flowers.

It is a sanctuary for thinking, relaxing, sketching and lessons. Prospective parents are taken here because it is tranquil with a living spirit. It is acknowledged by first Australians by a smoking ceremony.

This place is important to our community but will be gone if the school is demolished. It is clearly unviable to take the 10 beds with us to Wentworth Park. Hanging gardens cannot replace garden beds: trees cannot grow there. The kids pick fruit in the middle of Sydney.

The answer is to build a school fit for the future on Fig and Wattle where children can enjoy a safe open green space in which to play, relax, learn, garden and hold sports tournaments with neighbouring schools.

## DEMOUNTABLE CLASSROOMS

Mr Picolli told the Budget Estimates 2015/16 that he reaffirmed his comment from 2011:

"Every parent, teacher and student knows that learning in a demountable classroom is no alternative to learning in a real classroom. Our kids should not be languishing in secondrate facilities like demountable classrooms." He would prefer to have no demountables.

And yet Mr Riordan, Acting Secretary Education Department, told the Budget Estimates 2015/16 that "NSW has 5200 demountable classrooms".

Despite his stated preference, Mr Piccoli has chosen to send 300 children to demountables for three years, rather than buy land for a real school. That's 64,800,000 minutes for children.

## CHILDREN OF ULTIMO AND PYRMONT SHOULD NOT FUND BUDGET REPAIR

Since 2012 the Ultimo/Pyrmont area has provided at least \$150 million in Stamp Duty, on sales worth \$2,821,798,420.

Some of that was squandered on Learning Management and Business Reform (LMBR), for which the children should surely not be held responsible.

In Budget Estimates the Hon. Walt Secord asked the Minister "What are we up to now with Learning Management and Business Reform (LMBR)? What is the cost at this moment?" Mr Piccoli answered "It is \$752 Million."

# THE DEPARTMENT INSISTS ON CONSULTATION WITH THE COMMUNITY YET DEPARTMENT DOCUMENTS SHOW THEY KNEW OF VERY HIGH DISSATISFACTION

GIPA DGS15/917 25 May 2015: "There is a very high risk of community dissatisfaction with this decision, which is likely to lead to a concerted campaign to proceed with the purchase of the Wattle, Jones & Fig Street site.

...

"The Department proposes to mitigate these risks by quickly moving to prepare concept design options for redeveloping the existing Ultimo Public School site..."

After promising to work WITH the community to arrive at the best possible outcome for the school and community, the Department of Education routinely ignored communications from both the community at-large and the City of Sydney. We were being stonewalled at every opportunity.

## CONTACTING THE MINISTER'S OFFICE TO CONSULT WITH HIM

Our question was: Why are you not fully remediating Wentworth Park using the same policy that caused you to renege on the Fig and Wattle site - full remediation or nothing for our children?

It is very difficult to get any answers from the Minister who has not acknowledged our continuous calls to his department. We only get directed to a website with no answers.

## WENTWORTH PARK SITE : RECOMMENDATION TO COMPLETELY COVER CONTAMINATED SOIL TO PREVENT ANY CONTACT WITH THE SOIL

Posting from Mary Casey McLachlan Lister - Ultimo Public School Redevelopments Sept 2016: The main exposure pathway for lead and PAHs is ingestion of soil. Therefore the site can be made suitable by eliminating the potential for ingestion. We have adopted a very conservative approach to this issue and have recommended that the footprint of the school be completely covered to prevent any contact with the soil. This is a very common solution to this issue that has been implemented on many sites in Sydney.

## FIG & WATTLE SITE

The Department of Education has promoted a policy of fully remediating any land which they propose for a school. The Government reneged on a perfect site because of remediation costs, then proceeded to gather Human Health Assessments for a school on Wentworth Park which

is contaminated. Fully remediating is not what they are doing with Wentworth Park - they are capping.

### THE EDUCATION DEPARTMENT BLAMED THE CITY OF SYDNEY

In fact, during investigations we found the City of Sydney very accommodating concerning the site access - an example below:

#### New Inner City Primary School - Ultimo

I refer to your email about Ultimo Primary School and the sale of the City's former depot site at Fig and Wattle Street to the Department of Education and Communities for a new primary school. April McCabe, Policy Officer in my office tells me that she has spoken to you about your concerns and provided some information.

Since 2013, the City has worked in good faith to reach agreement with the Department of Education and Communities and achieve a positive result for the Ultimo/Pyrmont community. **Council, at its** meeting on 14 December 2015, reiterated its strong willingness to complete the sale of the Fig and Wattle Street, Ultimo site and authorised for me to again request a meeting with the Minister for Education, the Hon Adrian Piccoli MP to help achieve a new public primary school on this site.

Council also discussed general concern about the need for new schools to respond to the significant population growth, especially of families with children. The City of Sydney has long identified the provision of new primary and secondary schools as being critical, particularly to support high density living in areas like Ultimo as well as Green Square, but also more generally across the local government area.

I enclose a copy of Council's resolution and the letter I have sent to the Minister.

#### Access to the Fig and Wattle site

There have been false and mischievous claims that the City of Sydney refused access to the Fig and Wattle site and that this contributed to the Department of Education opting for the most expensive remediation option and subsequently deciding not to purchase the site.

The Department of Education requested access for both non-invasive (surveys) and invasive (drilling, bore holes) works on site. The City issued a draft licence agreement *allowing access for non-invasive works*, but raised concerns about the safety and general impact that invasive works, such as drilling and cliff face investigations would have on tenants on the site. *On 24 April 2015, the City and Department of Education's representatives agreed access to the site for the proposed invasive works would be 23 June 2015, the day after the remaining tenants had vacated the site.* 

#### Canada Bay Precedent

I would like to set the record straight about the recent joint venture between the Department of Education and Canada Bay Council as it has been cited as a precedent for the City of Sydney to offer the Fig and Wattle site to the Department free of charge.

A Council report in 2012 stated that the remediation cost was significant and Council was not in a position to undertake the works.

In addition to a new school on the site, the Department of Education agreed to provide the following additional facilities:

- a childcare centre
- a early childhood health care centre
- a purpose built Out of School Hours (OSHC) facility
- a multipurpose communal hall
- landscaping and upgrading work to the existing sports facilities in the Powell's Creek Reserve

The project also relocated a lapidary club and through the co-location of services, has freed other Council assets for new uses. While the Department of Education did not pay for the site, it provided at least equivalent value to Canada Bay Council by remediating the site and providing a wide range of new community facilities.

#### **Location of Temporary School**

A large number of concerned Ultimo Primary School parents and local residents attended this week's Council meeting and I have received numerous letters expressing concern about the NSW Government's decision not to purchase the site. Parents have told me how upset they are about the plans to demolish the current school, the uncertainty surrounding the location of the temporary school and the disruption to students being relocated.

On 14 September 2015, Council endorsed a Notice of Motion which noted that any option that disperses Ultimo Primary School students across other schools and outside the Local Government Area is unacceptable; and that the City would work with the Department of Education to minimise the disruption to students and the local community.

I was deeply disappointed with the NSW Government's decision to not purchase the site for a new primary school in Ultimo, particularly when an agreement had been reached in December 2014. The City has and always will continue to deliver local community facilities and strongly support the provision of new educational facilities to serve our growing population and where possible, assist the NSW Government to achieve that outcome.

#### RESOLUTION OF COUNCIL 14 DECEMBER 2015

#### NOTICE OF MOTION NO. 5 FIG AND WATTLE STREET DEPOT

It is resolved that:

- (A) Council note:
  - (i) on 8 December 2014, Council resolved to sell the former Fig and Wattle Streets Depot site to the NSW Department of Education and Communities for \$74 million and strata dedication to the City of an 80 place childcare centre, a reduction from the original \$82.5 million, subject to the construction of a public primary school and an 80-place child care facility on the site;
  - (ii) on 12 December 2014, the Minister for Education wrote to the Lord Mayor confirming the Department of Education's acceptance of the proposed purchase price of \$74 million with conditions, including access arrangements; and
  - (iii) on 12 June 2015, the NSW Department of Education wrote to the City advising they were rescinding their offer and would no longer proceed with construction of a public primary school site on the former Fig and Wattle Streets Depot site, despite the long-overdue demand by the local community for primary school places in the Ultimo area;
- (B) Council reiterate its strong willingness to complete the sale of the former Fig and Wattle Streets Depot site for a new public primary school and childcare facilities, or to support a range of other uses, including childcare and education; and
- (C) the Chief Executive Officer report back to Councillors at the earliest opportunity on the outcome of the work currently underway to appoint an Environmental Protection Authority Accredited site auditor to advise on and oversee the preparation of a Remediation Action Plan that could support the sale of the Fig and Wattle Streets Depot to the NSW State Government;
- (D) the Lord Mayor be delegated to commence negotiations with the NSW Government for the sale of the Fig and Wattle Street Depot for the provision of school and childcare facilities in Ultimo, noting that the proposed final sale price would need to be brought before Council for approval;
- the Lord Mayor report back to Councillors at the earliest opportunity on the outcome of negotiations; and
- (F) the Lord Mayor invite the Minister to brief Councillors on his plans to provide for the education of primary and secondary school children in the inner city area, not only on this site, but other sites in the Local Government Area, particularly Green Square.

Carried unanimously.
