INQUIRY INTO IMPACT OF THE PHASE-OUT OF AUSTRALIAN LIVE SHEEP EXPORTS BY SEA ON NEW SOUTH WALES

The time has come for the export of live animals, in this case sheep, to be a thing of the past. In the better world that we want, this barbarism has no place.

After a friend had been telling me of all the exciting things she had in her bucket list, like a new house, car, private education of her children, she asked me what was in my bucket list. I said that I would like to see the banning of live animal export before I die.

I was so excited to hear that Australia would be moving away from live sheep export on 1/5/28. Now I am heart broken that there is now some doubt that this may be set in stone.
