## Submission to the Inquiry on the Development Proposal for Rosehill Racecourse

Dear Select Committee,

- Instigate immediate action to improve racehorse welfare on the racetrack and off track by replacing current standards of welfare with those based on the 2020 Five Domains Model for animal welfare assessment, and require that members of the racing industry are educated accordingly.
- 4. Provide a fund to help transition members of the racing industry into professions outside racing.
