Dear Select Committee on PFAS Contamination in Waterways and Drinking Water Supplies Throughout New South Wales,

The focus of this Submission regarding PFAS Contamination in Waterways and Drinking Water Supplies Throughout New South Wales predominantly focuses on

PFAS contamination from the unregulated, out of control, Industrialised Solar/Wind Electricity Generating Works and Battery Energy Storage Systems whose fragile components contain and/or are coated with Toxic PFAS substances which can swiftly infiltrate the water table and local river systems, jeopardising both our quality of life and broader water infrastructure and will inevitably lead to Toxic Contamination of large tracts of limited, irreplaceable, life-sustaining Food resource land and vital Water sources such as local aquifers, wells, dams, bores and local creeks as part of the Catchment for the Murrumbidgee River - Wagga's water supply and throughout NSW/Australia. These Forever Chemicals are a persistent pollutant - linked to extremely serious, long term, detrimental health effects for humans and animals/wildlife as they contaminate water supplies and enter the food chain, accumulate and DO NOT degrade in nature or break down in our body. Neither are they suitable for sustainable recycling.

"Studies submitted to the U.S EPA by DuPont (which manufactures PFAs) from 2006 to 2013 show that they caused tumors and reproductive problems in lab animals. Perfluorinated chemicals also increase risk of testicular and kidney cancers, ulcerative colitis (Crohn's disease), thyroid disease, pregnancy-induced hypertension (preeclampsia) and elevated cholesterol."

It's not just the Toxic Solar Panels that are ignored - it's the Toxic Contaminating supporting infrastructure with PFAS coated Electrical Wiring, Inverters, Associated Infrastructure and Corroding Galvanized Steel Posts that
