## **RECKLESS RENEWABLES**

We are a farming community situated east of Dunedoo on the Golden Highway and within 5 kms of proposed works to do with the Birriwa Solar Farm.

We will be visually impacted by this eyesore and have not even been consulted.

The History of the Land surrounding our property is of a close knit community with up to 6 generations having looked after the land, making a living and producing food and fibre for our city counterparts who seem to not even know what is happening out here. Family farms are renowned for being the most efficient farmers. It is wonderful black soil country, perfect for the growing of all types of crops - wheat, oats, barley, canola, sorghum, cotton, lucerne for hay and many natural grasses. It is not at all suitable for solar "factories" or wind turbines 250mt tall.

For instance, when the country is wet it is untrafficable. When big rains occur the Talbragar River fills from White and Huxley Creeks and floods over properties in the vicinity. This is not the place for solar panels. Black soil sinks. Hail damaged solar panels would leak chemicals onto the soils which in turn would end up in the river and as far as the Murray River Basin. Livestock, grains and fibre could end up with chemical residue and unsaleable.

We have 3 generations currently living on Shingle Hut and what happens for our children and grandchildren in 20 years or when the panels break down or are obsolete? Too late to say "oh dear solar and turbines were not such a good idea" when the landscape is ruined.

These areas of Wind Turbines & Solar Panels are FACTORIES and not very good ones at that. They will not produce the amount of power required for base load to power factories and heavy duty organisations such as steelworks. They do not produce when the wind is not blowing and the sun is not shining. We notice turbines not working in many areas - either too much wind or the grid is full!!!

The proponents of the numerous turbine projects have no idea of life in the rural districts of every one of our states that is affected.

The proponents are politicians, bureaucrats and overseas companies sitting in their offices in our Federal & State Capitals who have never experienced rural life for a living and are absolutely blinkered with the narrow vision that renewables are the only goal they must achieve in the immediate future to save our planet.

Climate change and renewables have got the city people mesmerised. They believe everything they are told and many have never set foot out of their cities to see what actually happens in our rural areas. Do they think farming country is suitable for turbines. They should come and have a look.

The logistics of transporting turbine parts on the Golden Highway is incomprehensible. The highway is not adequate for the current traffic, let alone huge masses that will hold up traffic and block the flow of necessities like fuel going to the West of the State and cartage of livestock, grain and perishables to markets in the East. Accidents have already occurred with the transport of solar panels on this highway.

What amounts of concrete need to be made for the base of a turbine? Thousands of tons. How much energy is used to produce this concrete? Is this really "GREEN/RENEWABLE". I don't think so.

Regarding the close solar factory at Birriwa - tons of waste will be produced in this production ie. workers camp. Where will it go?

Workers' Camp - not a pleasant idea in the rural scene - producing more waste, need for water. Not being of any benefit to the townships nearby. Strangers coming as workers, possible crime, drugs etc. near farming families.

We are being bombarded daily with so many proposals all over the State of NSW and other states in the name of Renewable Energy. "Renewables" (a new buzzword for Governments), is all the Ministers for Planning, Energy and others involved can think of and we, the residents who make a living from the land producing food and fibre do not have the time to be reading and fighting all these ludicrous proposals.

We farming families do not have the time when running a business (or the resources such as are employed by the proponents writing thousands of pages of meaningless "gumph") to digest every section of it.

Why should we be expected and in some cases forced (with compulsory acquisitions) to ruin our land in making power for cities. It's about time the cities took responsibility for their own production of power by mandatory installing of solar panels on EVERY ROOF IN THE CITY. IT SHOULD BE MANDATORY FOR EVERY NEW HOUSE TO HAVE SOLAR PANELS AND A BATTERY HUB IN THE SUBURBS.
