NSW Government response to the inquiry of the Select Committee into the Proposal to Develop Rosehill Racecourse

March 2025

Introduction

The Legislative Council Select Committee on the Proposal to Develop Rosehill Racecourse (**the Committee**) was established in May 2024 to inquire into and report on the proposal to develop Rosehill Racecourse.

Background to the Rosehill Racecourse proposal

In December 2023, the Government announced the Australian Turf Club's (**ATC's**) intention to submit an unsolicited proposal to redevelop Rosehill Racecourse to allow for the development of up to 25,000 new homes, greenspace and other mixed-uses.

At this time, the Government separately announced that Sydney Metro would prepare scoping studies for up to two potential station locations west of Sydney Olympic Park as part of the Sydney Metro West project.

The unsolicited proposal would support the NSW Government's commitment to more housing in places where people want to live, and to improve affordability, reduce building and infrastructure costs and create thriving communities. If successful, The ATC has proposed that funds from the development could be invested in racing, training and member and spectator facilities at existing racing, training and stabling venues.

The proposal is subject to the NSW Government's Unsolicited Proposals: Guide for Submission and Assessment (May 2022), which include:

- strong probity, conflict of interest and confidentiality requirements, including the appointment of a probity adviser to advise, monitor and report at each stage of the unsolicited proposals process.
- requirements on proponents to refrain from lobbying Ministers or officials regarding the proposal, with clear communication channels established.
- clear assessment criteria, and a streamlined process for objectively assessing the public value of the proposal.

The Government's response to each of the Committee's recommendations is set out in the table below.
