

THE OPPORTUNITY

The Communications, Engagement and Education branch of the Department of Parliamentary Services at the Parliament of NSW will commission a series of artists to create an interpretation of the façade. The parliament house facade is central to our identity as Australia's oldest parliament and the design is celebrated in corporate imagery from annual reports to Christmas cards and externally through our event promotion, public tours and school programs.

We are seeking expressions of interest from artists with strong connections to New South Wales. Aboriginal, LGBTQIA+ and/or rural, regional, and remote artists, as well as emerging artists, are strongly encouraged to apply.

THE OPPORTUNITY

Artists will be tasked with creating digital concepts that explore and highlight themes such as history, modernity, inclusivity, resilience, providing a lens through where their unique perspective of the Parliament of NSW can be explored.

The artists' designs will be shared with the public and adapted for various mediums, including but not limited to:

 online, social media, print collateral, murals, 3D models for utilisation in children's craft activities, light installations, gift shop merchandise, and digital displays.

CONTRACT

Once the expression of interest is complete, the selected artists will enter into a commissioning agreement contract with the Parliament of NSW.






EXPRESSION OF INTEREST

ARTIST FEE

An artist fee of \$6050 AUD (plus GST) will be paid in a single instalment upon delivery of the completed artwork to agreed brief and specifications, and on the condition of the signed contract and acceptance of the design.

The artist fee is inclusive of all design production costs including materials, travel, tools and fabrication, as well as licensing of the artwork for commercial and non-commercial use.





EXPRESSION OF INTEREST

SELECTION PROCESS

Selection process:

- 1. Artists must respond to this EOI by 11.59pm,16 March 2025
- 2. Applications will be assessed against the selection criteria
- 3. One design per artist, where up to three separate artists will be selected for production
- 4. The successful artists will each enter into a commissioning agreement contract with the Parliament of NSW to produce and deliver the design

The selection panel will be comprised of NSW Parliament staff.



EXPRESSION OF INTEREST

SELECTION CRITERIA

Selection criteria:

- 1. Alignment to the design brief, including suitability for digital and physical realisations of the artwork
- 2. Artistic experience and ability to deliver the work on time
- 3. Must reside in New South Wales



EXPRESSION OF INTEREST

DESIGN BRIEF

- 1. The design will illustrate/feature/represent the iconic façade of the Parliament of NSW, as seen from Macquarie Street
- 2. The design will interpret the façade with an apolitical artistic representation through which the artist's unique perspective of the Parliament of NSW can be explored while remaining recognisable as the parliament house facade
- 3. The design will have a strong connection to the iconic façade and explore themes such as history, modernity, inclusivity, and resilience
- 4. An understanding of the unique role of the parliament that allows the people of NSW to be welcomed, see themselves represented and engage with the parliament in meaningful ways



SOCIAL MEDIA STRATEGY

DESIGN BRIEF

- 5. The design will be unique and the artists' own work, without the use of Al tools
- 6. The design will be appropriate in scale and form for the potential uses outlined in the toolkit, including print and digital use
- 7. The design should be an image that does not need to be reproduced in its entirety. It should be an image that can be cropped or its details used for various applications
- 8. The design should take into consideration its viability as a monochrome or tinted design



EXPRESSION OF INTEREST

DESIGN BRIEF

- 9. Alongside the final artwork, the artists will also deliver a supporting statement of approximately 200 words describing the meaning, story, inspiration or influences behind the design
- 10. Offensive submissions will not be considered



EXPRESSION OF INTEREST

SPECIFICATIONS

- 1. The final artwork must be delivered as scalable vector files and/or as a raster image file minimum A3 at 300 DPI or 50 Mb file size
- 2. Acceptable file formats include TIFF, JPEG and PNG





EXPRESSION OF INTEREST

EOI REQUIREMENTS

- 1. Contact details (full name, address, email and phone number) and ABN, if applicable
- 2. Design concept (hand drawn or digitally rendered) with a supporting statement outlining the artistic approach and how the final artwork will be realised
- 3. Artistic experience: CV, website or digital portfolio outlining your experience, style and achievements
- 4. Availability: Must adhere to the outlined timeline, including review and approval dates, to deliver the artwork if selected
- 5. Community: Advise if you identify as Aboriginal, with strong connections to a First Nation country/countries in New South Wales, identify as LGBTQIA+, and/or are an artist living in remote, regional, or rural New South Wales.



EXPRESSION OF INTEREST

SUBMITTING THE EOI

EOI submissions must be received by the deadline: 11.59pm, Sunday 16 March 2025.

If the artist wishes to conduct a site visit to inform their submission piece/s or during the design process, in the case of the successful artist, the parliament is open to the public Mon – Fri, 9am – 5pm.
